WE CANNOT HOLD SPACES WITHOUT A COMPLETED SHOW CONTRACT. **Contracts received after September 1st are subject to a 5% monthly increase in booth price. Any unpaid balances after September 1st are subject to a 5% monthly late fee. No Exceptions.**
